- 1. Call to Order Chair Dederick called the meeting to order at 2:17 p.m. in the Sage Stage Conference Room, 108 S. Main Street, Alturas, CA.
- 2. Public Forum There were no public comments.
- 3. Confirm Agenda Motion by Board Member Rhoads to Confirm Agenda, seconded by Board Member Cavasso. All Ayes; motion carried.

## 4. Consent Agenda-

**a.** Approve minutes from the February 7, 2023, MTA Regular Meeting.

#### 5. Regular Business

a. Consider adopting Resolution 23-01 Fiscal Year 2023/24 Budget.

Pedersen reported the MTA will be utilizing FTA 5311 & 5311(f) CARES round 2 COVID-19 grant funds increasing revenue. The increase reduced the MTA LTF allocation apportionment needed for FY 2023/24. Expenses increased slightly for accounting / auditor services.

Motion by Board Member Minchella to adopt Resolution 23-01 Fiscal Year 2023/24 Budget, seconded by Board Member Nelson. All Ayes; motion carried.

**b.** Consider approving the 2023 Title VI update.

Federal Transit Administration and Caltrans require the Title VI Plan be updated every 3 years. The last update was in 2020. While reviewing the draft Title VI plan, Board Member Cavasso discovered information on page 18 of the document that requires some updates. Executive Director, Pedersen will review the information before the final draft is submitted.

Motion by Board Member Cavasso to approve the 2023 Title VI Plan update, with the changes to page 18 of the document, seconded by Board Member Moriarity. All Ayes; motion carried.

c. Consider adopting Resolution 23-02 Federal Transit Assistance Funds.

The Federal Transit Administration (FTA) started requiring an Authorizing Resolution for FTA 5311 and FTA 5311(f) grant funding with the California Department of Transportation. This resolution will be an annual requirement.

Motion by Board Member Minchella to adopt Resolution 23-02 Federal Transit Assistance Funds, seconded by Board Member Nelson. All Ayes; motion carried.
